Review of Rules and Guidelines for the Advisory Committee meetings (Lauren Hadley)

Program Update and Status Report (Rosie Bellert)

Personnel changes: Lori now First Year Lead on full time temporary 1 quarter contract, tenured position to open soon; Glenda now Patient Coordinator for new patients and continuing care, Dentrix

Board Results and Employment (Rosie Bellert)

All 24 graduates employed, 2 students repeated and passed the National Board, Second Restorative board taken and passed by 3 students

WA State Legislative Session Update (Richard Burton, AFT)

2019 legislative session in a good moment for funding 2-year colleges, extra revenue available
K-12 complied to McCleary decision and favorable majorities to support education
AFT engaged in campaign to talk to State Legislators from view point of workforce and industry
Vision 2023: 70% of WA state students (16-24 yo) to have a higher education degree
Circulated petition to return by November 20, 2019 to Senate Ways and Means Committee

Update of Advisory Committee Role (Lauren Hadley)

Goal is to engage Advisory Committee. What are industry needs? What are the current trends?

Ideas: informational interviewing

Handbook goals: meeting workforce needs of community, want "new faces" and set term limits to 3 years. Recommendations from State Boards to membership composition. Need 8 members (50%=quorum). Add 1 annual meeting and have 3 meetings per year. Across campus, annual plan of action – reviewed Handbook Focus areas 1-7.

Discussion on 3 year term limits: long term involvement (Marianne), different perspectives (Tracy), confident to have a voice after listening (Jennifer), profession not industry (Melinda), incentives to new members (Nikki), involve graduates (Lauren), open to change, not stagnate and get new people too (Debbie), recruitment of 5-12 industry members by visiting, "DACUM" with outcomes mapping (Lauren)

Update on BASDH proposal to SCC (Rosie)

SCC Task Force February-March 2019, goal is May 2019 approval and start first class 2020

Dental Hygiene will be the first Bachelor level program at SCC
